





# 2025 Top 10 Accomplishments



## 1 Rocking the On Street Projects

2025 brought the birth of our **Downtown SmART Streets** project! In our inaugural year, we installed curb extension murals at **E. Main & Gibbs** and **Broad & Fitzhugh**. We also completed our **5th Complete Streets Makeover** project that transformed the intersection of **Avenue D & Hollenbeck St** in the El Camino neighborhood. Shout out to all our community partners and to project manager extraordinaire, Lourdes Sharp, for phenomenal work!



injuries down to zero. We started the year helping put together the Beacon's **Vision Zero Forum** and packed the house with "Reconnecters" for encouragement & input. We've been highly engaged serving on the **RVZ Task Force** and its subcommittees, and in June, took a trip to Albany with **Councilmember Gruber** and others to learn lessons from their Vision Zero experiences. We've talked it up in the media, helped the public understand all the parts (like what does **Bus Rapid Transit** have to do with safe streets?), and informed the implementation of new bus arm cameras and other aspects of the RVZ plan.

We also spent time honoring lives lost, connecting with families, developing support networks, and gathering people with a **World Day of Remembrance** vigil and installation on Parcel 5. Connecting to the personal pain of crash victims motivates us to keep up the work to make our streets safer, to save lives and reduce the harm inflicted by road violence.

## 2 Standing Up for Public Transportation

In 2025, our advocacy team worked alongside **New Yorkers for Transportation Equity** and **VOCAL-NY**, on the **Get Around New York** campaign that asks for accessible, reliable, affordable public transportation for all New Yorkers. We gathered rider voices and experiences through **Voices of Transit** interviews to share with lawmakers on **Transit Equity Day** in Albany, and hosted several town hall meetings with local RTS riders to strategize efforts that center and uplift transportation needs. We gathered local partners to sign on to a letter to Governor Hochul urging full funding. Unfortunately, our funding asks were not fully met, but we built a lot of power to fight for funding in the coming year, and avert a budget crisis that could lead to service cuts.

## 3 Partnering on ROC Vision Zero

We partnered with the city of Rochester toward the bold goal to bring the number of traffic fatalities and severe



## 4 Fighting Nationally & Celebrating Locally on Bike Infrastructure

In 2025, we sounded the alarm on the **assault on bike infrastructure** as we saw the gains and investments in recent years under threat. Our advocacy team stayed in close contact with **national advocacy groups** on response strategies, gave local cyclists opportunities to take action, and in March, visited Capital Hill to share our concerns directly with federal legislators.

At home we continue to see slow and steady investment and progress throughout **Monroe County**. We cheered the first ever **concrete barrier-protected bike lane** on West Main Street, unveiled a new **Bike Spine Tracker** tool, and hosted our 5th **Mind the Gap** public voting campaign to highlight critical gaps. In August, nearly 100 area cyclists came out for our **Keep Us Safe on State Roads rally** to send a strong message to NYSDOT for safer infrastructure on state controlled roads.



# 5 Getting More People On Bikes Riding Together

Community rides all summer long in partnership with the City of Rochester & Brighton Recreation, **Light Up the Night** rides, bike to work pitstops, bike history tours, and our annual **ROC 'n Roll** ride – all get people on bikes and riding together! In May, we coordinated **Rochester Bike Week** and kicked it off with Mayor Evans and County Executive Bello who gave a rousing Bike Month Proclamation! We also worked to inspire and engage people online with @ROCCycling social media channels and a **#ROCbyBike** series where everyday bike riders share why they love to get around on two wheels.



# 6 Keeping Cyclists Safe on the Road

In 2025, we continued our classroom and **on-bike education**. We were thrilled to sponsor Hulda Yau to become Rochester's first **Spanish-speaking certified bike educator**, and partner with Ibero-American Action League to deliver bike education classes to Spanish speaking residents. We also struck up a new partnership with **Rochester Refugee Resettlement** to offer classes to Syrian residents in their own language. As part of our commitment to equity and inclusion, we removed the cost barrier by making our on-bike Smart Cycling classes free. We also keep our area's pool of League Cycling Instructors (LCIs) busy teaching learn to balance and ride classes in City Rec Centers!

Online resources like our custom bike route assistance, **ROC Easy Bike Map**, and educational blog content offer routes and tips to safely move around our community on two wheels. This year, we also made a poster drawing attention to our resources and dropped one off at every bike shop in Monroe County!



## 7 Engaging & Spreading Our Vision

Through engagement breakfasts, presentations, tabling, lunch and learns, walking tours, and a packed Rochester Street Films event, we spread the word to every corner of our community to get involved in our local mobility movement.

We expanded our media presence on podcasts, radio shows, and news stories including a segment in the national outlet **Strong Towns!** Our new ROC edition of **Week Without Driving** saw 44 participants logging 616 non-car trips and 1,970 non-driving miles!

And that's not to mention our weekly mobility action alerts, a ROC neighborhood leaders conversation, convening a **town & village advocate group**, and producing a **candidate questionnaire** to inform your vote!



## 9 Bolstering Our Organizational Leadership

In January we welcomed three incredible new members; **Josie McClary, Steve Roll, and Katie Austin** with diverse backgrounds and shared commitment to making a meaningful impact. The Board of Directors appointed Mary Staropoli and Cody Donahue as the organization's **Co-Executive Directors**. In an announcement blog, we shared why we made the shift to a shared leadership model, what makes it work, and Mary and Cody's respective areas of focus.



## 8 Putting a Spotlight on Land Use & Zoning

Building on 2024's **The Sprawl Effect**, we continued to raise consciousness around the costs and consequences of our auto-centric land use policies. We joined with community partners in holding several workshops throughout the year promoting denser, mixed use zoning along transit corridors and **eliminating parking minimums** to spur housing in-fill development, and sharing the economic analysis offered by Urban3.



## 10 Finding Our New Home!

After a lengthy search process, in September we packed up and moved our offices from The Hungerford (our home for the last 9 years), to a new home at the **Harro East in downtown ROC!** We can't believe our luck in finding a place that fit all our needs that will serve as both an office space for our growing staff team, as well as a "community hub" to host events, meetings, classes and conversations. And we get to be part of all the exciting development downtown, including having a front row seat to the **Inner Loop North development** as it happens in the coming years!

Over 100 people came through our **October Community Open House**, and we've welcomed many more as we begin to make good use of the awesome space. A ribbon cutting with the **Chamber of Commerce, Mayor Evans and County Executive Bello** in November made it official.

# 2025 Mobility Updates

As we look around the transportation landscape in Monroe County, we can note a few big wins, lots of little wins, and some challenges for mobility in 2025.

## PUBLIC TRANSIT

While we continue to urge the full implementation of the Reimagine RTS system redesign, RTS has made some positive strides and also faced headwinds to fulfilling its promise of a strong transit system. For example:

- Senator Cooney secured \$250,000 for the study of a **Bus Rapid Transit** line which became a 15 minute frequent route in 2024.
- RTS has implemented new payment methods at the farebox, making it easy to swipe credit cards and other new payment methods.
- With higher starting wages in RTS Monroe, **bus operator recruitment** is up.
- State operating funding was increased by 4.88%, and the capital plan added \$80 million for upstate transit.
- **Bus stop improvements** in the City of Rochester are still in progress, with the majority of improvements planned to be completed by 2027.
- **Safety improvements** such as mirrors to see pedestrians and protective shields for operators are continuing.
- Service changes to RTS On Demand were implemented, in spite of advocate and resident concerns.
- RTS expanded their **zero-emission fleet** with more hydrogen buses.
- Continuing partnership with the City of Rochester to **remove snow** from shelters.

## INTERCITY BUSES, INTERMODAL STATION AND INNER LOOP NORTH

- Rochester was awarded \$100M in federal funding for the **Inner Loop North redevelopment project**, representing nearly half of the project cost. The project is expected to start in 2028.
- Rochester completed a land use study to look at possible ways to use the 22 acres of new developable land in the downtown core.
- We're closely following and advocating for progress on building the expansion of the **Rochester Intermodal Station** to include intercity buses following an \$18M NYS budget win in 2024.
- We collaborated with the City of Rochester to add seating and **Downtown Rocs** to add planters, signage, and enhanced trash pickup at the Pleasant St. FLIX/Greyhound stop.





# 2025 Mobility Updates

## BUILDING THE BIKE SPINE AND COUNTY BIKE LANES

Building on the 2023 Active Transportation Plans, the city and county built new bike infrastructure in 2025:

- A major development was the **West Main Street seasonal concrete barriers** deployed to protect cyclists!
- **Cycletracks** were installed on **Genesee St** and **University Avenue**.
- Bike boulevards phase 3 in the City of Rochester is moving forward and the **Town of Irondequoit** installed **bike boulevard markings**.
- Monroe County proposed several road diets to create more bike space on county roads and has continued to budget for bike infrastructure.



## ROC VISION ZERO PROGRESS IN THE CITY OF ROCHESTER

The City of Rochester is making progress on all areas of its 10 point plan to address traffic related injuries and fatalities. The **Bus Arm Camera** program launched in the City in late 2025 and public engagement on **Automated Enforcement** will take place in spring 2026.



## LAND USE AND TRANSIT SUPPORTIVE DEVELOPMENT

A coalition of organizations has trained residents to speak to town boards about **inclusive zoning** and **transit supportive development**.



## MORE MOBILITY WINS

VEO continued to exceed expectations in Rochester: the program set a **new ridership record** with over 567,000 trips in the 2025 season, a 33% increase from 2024. The geographical zone expanded to include most of **Maplewood** and the season extended from March to December. Could the suburbs be next?

A Genesee Transportation Council-supported study on an employment focused transportation management association was completed and a community coalition is meeting to discuss forming a new entity to help people connect to jobs.



# 2025 Advocacy Work

## *by the numbers*

Our advocacy team works hard every day – on stage and behind the scenes – to build relationships with community decision makers, to champion mobility at many tables where transportation decisions are made, and to let community advocates know what actions they can take to support the effort. All these connections and actions play a big part in the wins for mobility you just read about!


# 2025 Financial Review

Over the last number of years, Reconnect Rochester has grown tremendously and hired an all-star team of seven full-time staff members (see page 3) who work every day to move our mission forward. As you can see in the pages of this report, a staffed organization has allowed us to expand our power and impact across Monroe County! In 2025, we adopted a shared leadership model (see #9 on page 6) and added a full-time Fundraising & Development position as investments in our future sustainability. We also moved into a new downtown office space that now serves as a home base for our team and a warm place to welcome in the community to be part of our work (see #10 on page 6).

Along with growth has come a significant increase in our staffing and overhead expenses, and our annual budget now exceeds \$550,000. Thanks to the generosity of many individuals, foundations and corporations (listed on pages 12-14), Reconnect Rochester has comfortably handled our budget growth and remains on solid financial footing, taking in as much as we spent in 2025.


The following charts reflect the diversity of our income sources, as well as responsible spending on operational expenses.
